A. CONTROL #2022-09-03 – WEST BONNER COUNTY SCHOOL DISTRICT #83 – DOORHANGER FEES REIMBURSEMENT REQUEST

Steffie Pavey from the West Bonner County School District, 134 Main Street, was present to give the Council an update on the District's policy regarding paying the bills. Discussion ensued.

Council Member Mullaley made a motion to approve reimbursement to the West Bonner County School District for twelve doorhanger fees, at \$35.00 each. Council Member Yount seconded the motion. After consideration, the motion passed unanimously.

Council Member Yount made a motion to approve Pay Request #4 for Tork Electric, Inc. for the Wastewater System Improvements Project, in the amount of \$3,051.88. Council Member Mullaley seconded the motion. After consideration, the motion passed unanimously.
