

**ORDINANCE NO. 576**

**AN ORDINANCE ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR FISCAL YEAR BEGINNING OCTOBER 1, 2015, APPROPRIATING THE SUM OF TWO MILLION ONE HUNDRED EIGHTY-NINE THOUSAND TWENTY-SEVEN DOLLARS AND NO CENTS (\$2,189,027.00) TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF PRIEST RIVER FOR SAID FISCAL YEAR, SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE, AUTHORIZING A LEVY OF SUFFICIENT TAX UPON THE TAXABLE PROPERTY, PROVIDING FOR REPEAL OF CONFLICTING ORDINANCES, DIRECTING THE CITY CLERK TO FILE CERTIFIED COPIES OF THIS ORDINANCE WITH THE COUNTY COMMISSIONERS AND IDAHO SECRETARY OF STATE, AND PROVIDING FOR AN EFFECTIVE DATE.**

**Be it ordained by the Mayor and Council of the City of Priest River, Bonner County, Idaho:**

**SECTION I:** That the sum of **TWO MILLION ONE HUNDRED EIGHTY-NINE THOUSAND TWENTY-SEVEN DOLLARS AND NO CENTS (\$2,189,027.00)** be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Priest River, Bonner County, Idaho for the fiscal year beginning October 1, 2015.

**SECTION II:** The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:

**SECTION III:** That a general tax levy on all taxable property within the City of Priest River be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2015.

**SECTION IV:** All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

**SECTION V:** The City Clerk of the City of Priest River is hereby directed to file a certified copy of this Ordinance with the County Commissioners of Bonner County, Idaho, and the Idaho Secretary of State, in accordance with Idaho Code 50-1003 and 63-804.

**SECTION VI:** This ordinance shall take effect and be in full force upon its passage, approval, and publication in one issue of the Priest River Times, a newspaper of general circulation in the City of Priest River, and the official newspaper of said City.
